



**Village Roads:** **Fall:** Leaf pickup in the fall runs from October 15<sup>th</sup> through December 1<sup>st</sup>. There will be no pickup after December 1<sup>st</sup>. All leaves must be bagged for pickup. Branches will also be picked up but must be tied in bundles no larger than 4 ft. long and 18 in. in diameter. Leaves and branches that are mixed with debris will not be picked up.

**Spring:** Leaves must also be bagged for spring pickup. Branches must be bundled as above. The following roads are maintained by the Village of Lattingtown:

**County Roads:** As many of you know, the County in past years has cleaned up County maintained roads in springtime for leaves, branches and other garden debris. However, because of manpower shortages that service will no longer be available. Despite the foregoing policy, the County does from time to time in the fall pick up leaves that are blocking storm sewers. However, residents on County roads should not count on that service but find other means of disposing of this material. It may not be left by the side of the road or residents will be subject to fines under the Village ordinances.

**Parking:** A reminder—There is no parking permitted on any road in the Village except by special permission of the Board. Call the Village Clerk (516-676-6920) if you are planning a function requiring on-street parking. Note: boats and RVs may only be parked on residential property if visible to the street for not more than 30 days in any calendar year.

**Noise Ordinance:** There are limitations on the hours construction and landscaping equipment may be used. Heavy construction equipment: 8:00 am to 6:00 pm Monday through Friday; no use permitted on Saturday, Sunday and holidays. Landscaper's power equipment: 8:00 am to 6:00 pm on Monday through Friday, 9:00 am to 4:00 pm on Saturday. No use permitted on Sundays and holidays. Homeowners must adhere to the same schedule with the exception that they may use landscaping equipment from 10:00 am to 3:00 pm on Sundays and legal holidays. Please contact our Village Clerk for a copy of the ordinance.

**Lighting Ordinance:** The Village has an ordinance limiting the use of floodlights and decorative lighting around houses. All lights need to shine downward and may not shine onto your neighbors' properties. View the ordinance online or call the Village for a copy.

**Dog Ordinance:** We have an ordinance in the Village to protect residents from dogs that are dangerous or annoying neighbors by continuous barking. Complaints should be directed to our Village Clerk, or in her absence our Village attorneys—and in an emergency, Nassau County Police.

**Lattingtown Village Beach:** Available for our residents' use for a fee of \$150.00. Nonresidents may also belong to our Village Beach for \$250.00 if sponsored by a resident. Please visit our website, [www.villageoflattingtown.org](http://www.villageoflattingtown.org), for an application.

**Fence Permit:** The Village has a new fence ordinance. If you are installing a new fence, please complete a fence application which can be downloaded from the Village website and submit it to the Building Department with a fee of \$150. Please remember that the good side of the fence must face out and a fence may be not more than 6 ½ feet high.

**Shredding Day:** Residents may bring up to 3 boxes of personal documents on Saturday, October 14<sup>th</sup> from 9 am to noon. The documents will be shredded on site.

**Glen Cove Golf Course:** Membership in the golf course is available to Lattingtown residents at a reduced rate and upon approval by the Glen Cove Golf Commission. Residents are defined as property owners, their immediate family members residing with them, or people legally renting in the Village on a year-round basis. Upon request, our Village Clerk can confirm property owners, but renters must obtain a letter from their landlords confirming that they are renting in the Village on a year-round basis.
